HOUSE FLOOR AMENDMENTS

Amendments proposed by Representative Barras to Engrossed House Bill No. 1 by Representative Tucker

AMENDMENT NO. 1

On page 7, delete lines 7 through 10 and insert the following:

"(46) District 46 is composed of Precincts 9-1, 9-2 and 11-4 of Iberia Parish; Precincts 3-1, 3-3, 3-5 and 3-6 of St. Landry Parish; and Precincts 1-4, 3-4, 3-5, 4-1, 4-1A, 4-2, 4-4, 4-5, 5-1, 5-2, 5-3, 5-4, 6-1, 6-2, 6-3A, 6-3B, 6-4, 7-1A, 7-2A, 7-4, 7-4A, 8-1, 8-3, 8-4, 8-4A, 9-1, 9-2, 9-3, 9-4 and 9-5 of St. Martin Parish."

AMENDMENT NO. 2

On page 7, delete lines 15 though 18 and insert the following:

"(48) District 48 is composed of Precincts 2-3, 3-1, 3-2, 3-3, 5-4, 6-1, 6-4, 7-1, 7-2, 7-3, 7-4, 7-5, 8-1, 8-2, 8-4, 8-5, 9-3, 9-4, 9-5, 10-2, 14-1 and 14-3 of Iberia Parish; Precincts 101, 102, 103 and 110 of Lafayette Parish; and Precinct 2-2 of St. Martin Parish."

AMENDMENT NO. 3

On page 12, delete lines 25 through 28 and insert the following:

"(93) District 93 is composed of Precincts 1-1, 1-2, 1-3, 2-1, 2-2, 3-4, 4-1, 4-2, 4-3, 4-4, 5-1, 5-2, 5-3 and 6-2 of Iberia Parish; Precincts 54, 55, 56, 99 and 100 of Lafayette Parish; and Precincts 1-1, 1-3, 1-7, 2-1, 2-3, 2-4, 3-1, 3-1A, 3-1B, 3-2, 3-3, 3-4A, 3-6, 3-9, 4-3, 4-4A, 4-6, 6-2A, 6-3, 7-1 and 7-3 of St. Martin Parish."

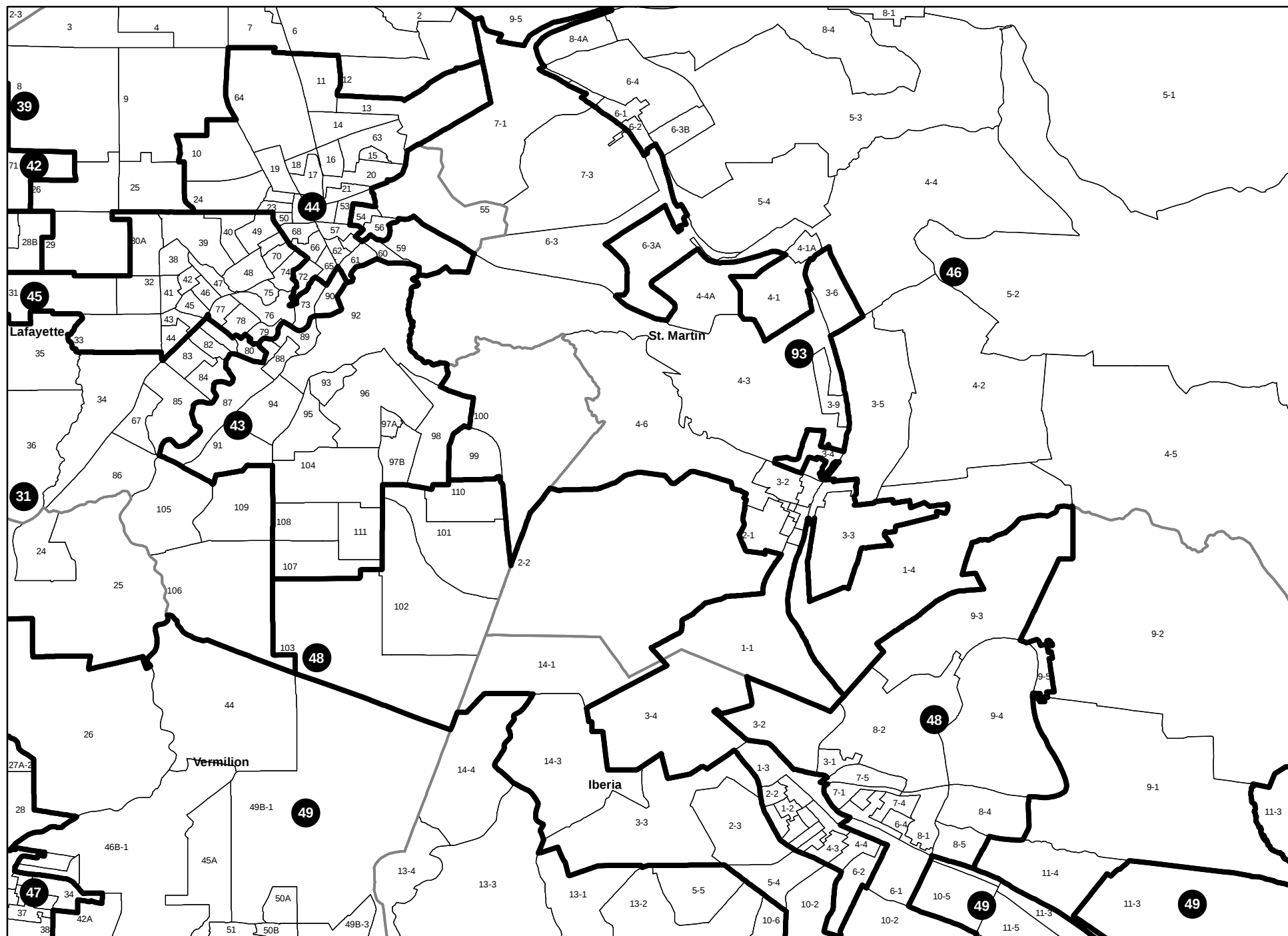
