Amendments proposed by Representative Burrell to Engrossed House Bill No. 1 by Representative Tucker

AMENDMENT NO. 1

On page 1, delete lines 15 through 17 and insert the following:

"(2) District 2 is composed of Precincts 2-5, 2-6, 2-8, 2-13, 2-23, and 4-8D of Bossier Parish and Precincts 6, 7, 8, 15, 17, 27, 28, 29, 30, 31, 32, 37, 39, 40, 41, 44, 46, 54, 64, 67, 71, 98, and 99 of Caddo Parish."

AMENDMENT NO. 2

On page 2, delete lines 3 through 15 and insert the following:

"(5) District 5 is composed of Precincts 4, 23, 24, 34, 35, 38, 50, 51, 52, 58, 59, 68, 78, 79, 91, 92, 93, 94, 95, 103, and 126 of Caddo Parish.
(6) District 6 is composed of Precincts 1-1, 1-2, 1-3, 1-4, 1-4A, 1-5, and 4-8C of Bossier Parish and Precincts 9, 10, 11, 12, 13, 14, 16, 20, 21, 22, 26, 48, 49, 72, 75, 76, and 129 of Caddo Parish.
(7) District 7 is composed of Precincts 56, 77, 97, 101, 102, 104, 107, 108, 109, 110, 125, 127, and 128 of Caddo Parish; Precincts 3, 10, 11, 12, 16, 19, 21, 22, 23, 28, 29, 30, 35, 36, 46, 47, 48, 49, 50, 51, 53, and 58 of De Soto Parish; and Precincts 1-1, 1-2, 2-1, 2-3, 3-1, 3-2, 3-3, 4-1, 4-2, 7-1, 7-2, and 7-3 of Red River Parish.
(8) District 8 is composed of Precincts 2-1, 2-2, 2-4, 2-7, 2-9, 2-10, 2-11, 2-11A, 2-12A, 2-12B, 2-12C, 2-14, 2-16A, 2-17A, 2-17B, 2-18B, 2-18C, 2-19, 2-20, 2-21A, 2-21B, 2-21C, 2-21D, 2-22A, and 2-22B of Bossier Parish."

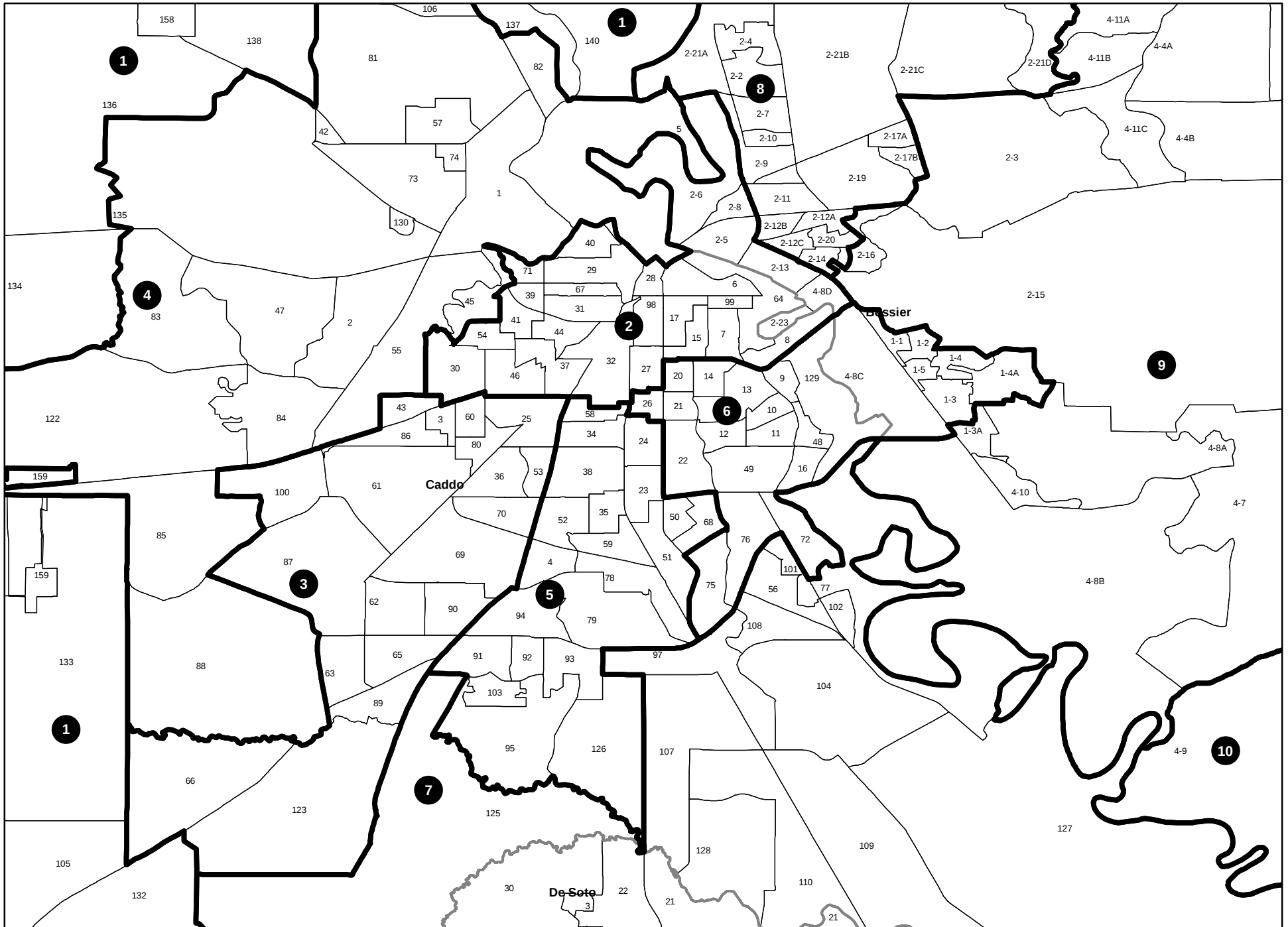

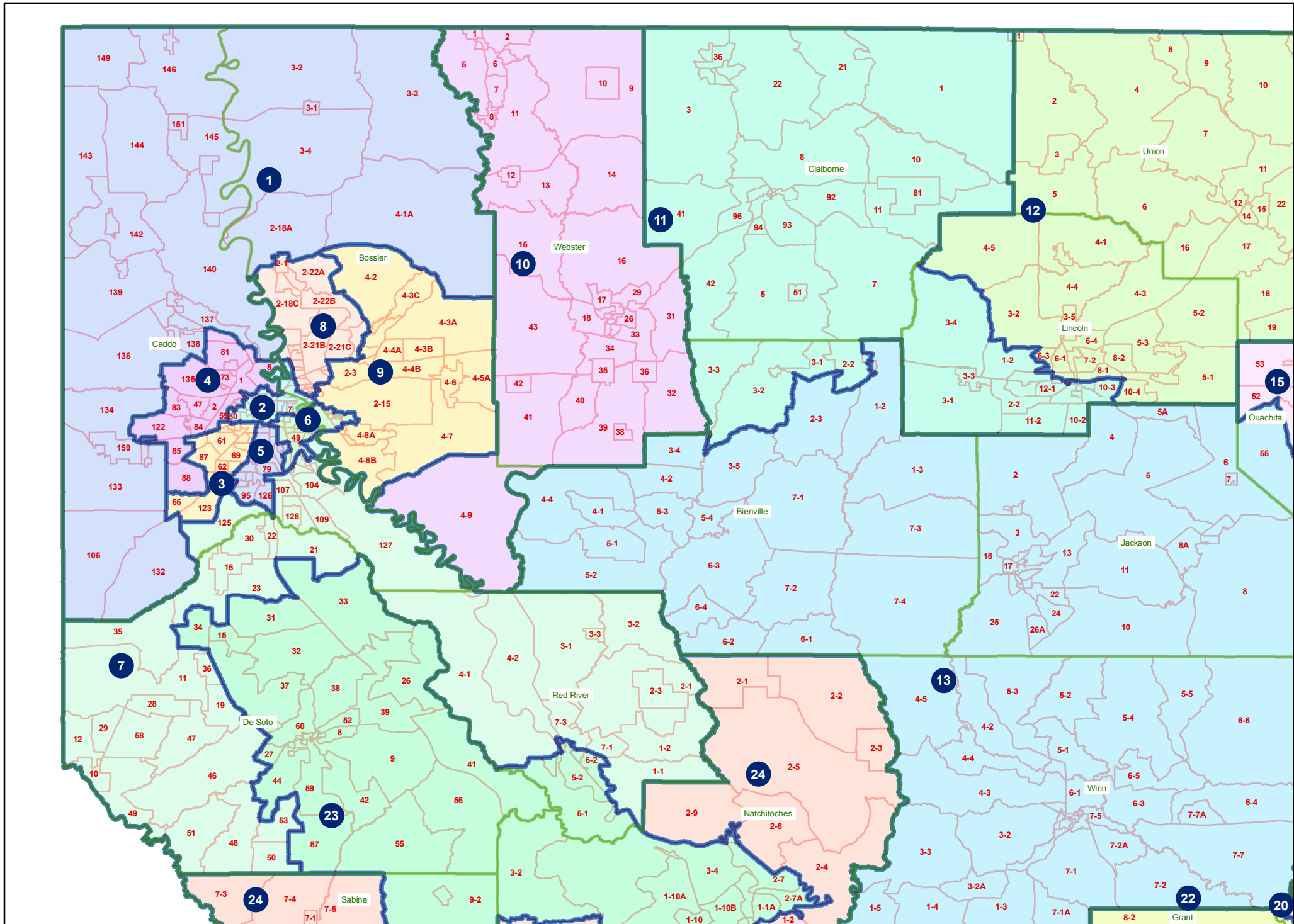
