Amendments proposed by Representatives Brossett, Abramson, and Leger to Engrossed House Bill No. 1 by Representative Tucker

AMENDMENT NO. 1

On page 12, delete lines 16 through 20 and insert the following:

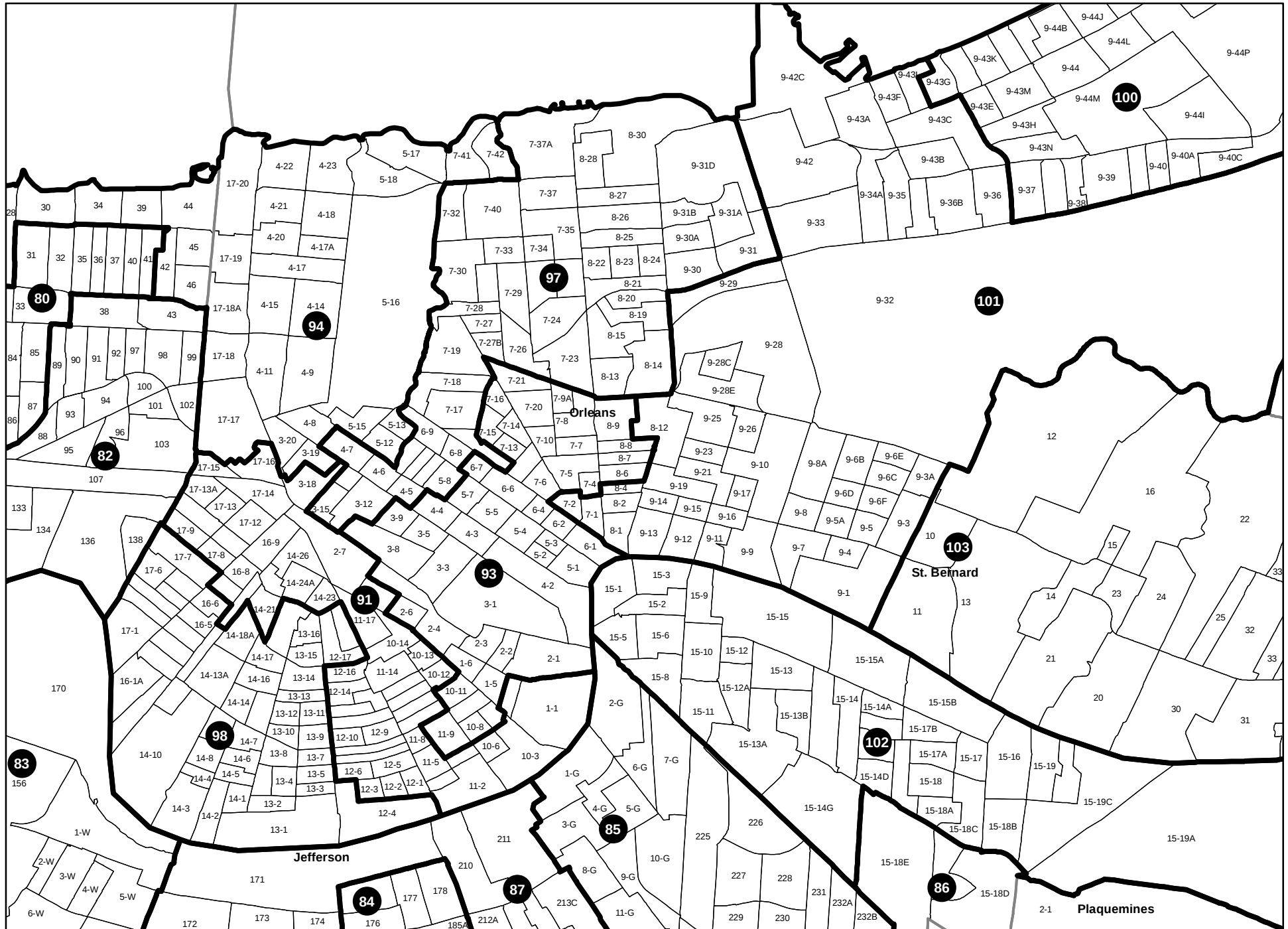
