"(2) "Equine Farm animal" means a <u>one or more of the</u> following domesticated animals: horse, pony, mule, donkey, <del>or</del> hinny, cow, ox, sheep, pig, hog, goat, ratite (ostrich, rhea, emu), and chicken or other fowl.

(3) "Equine Farm animal activity" includes any or all of the following:

(a) An equine <u>A farm animal</u> show, fair, competition, performance, or parade that involves any or all <del>breeds of equine and any of the equine disciplines</del> farm animals, including but not limited to any dressage, hunter and jumper horse show, grand prix jumping, three-day event, combined training, rodeo, driving, pulling, cutting, polo, steeplechasing, English and western performance riding, endurance trail riding, and western game and hunting.

(b) Equine training <u>Training</u> or teaching activities, or both, <u>involving farm animals</u>.

(c) Boarding equine a farm animal, including daily care.

(d) Riding, inspecting, or evaluating an equine <u>a farm animal</u> belonging to another, whether or not the owner has received some monetary consideration or other thing of value for the use of the equine <u>farm animal</u> or is permitting a prospective purchaser of the equine <u>farm animal</u> to ride, inspect, or evaluate the equine <u>farm animal</u>.

(e) A ride, trip, hunt, or other equine <u>farm animal</u> activity of any type however informal or impromptu that is sponsored by <del>an equine</del> <u>a farm animal</u> activity sponsor.

(f) Placing or replacing horseshoes <u>or trimming the hooves</u> on <u>an equine a farm animal</u>.

(g) Examining or administering medical treatment to <del>an equine</del> a farm animal by a veterinarian.

(4) "Equine Farm animal activity sponsor" means an individual, group, club, partnership, or corporation, whether or not the sponsor is operating for profit or nonprofit, which sponsors, organizes, or provides the facilities for an equine <u>a farm animal</u> activity, including

but not limited to: a pony club; 4-H club; hunt club; riding club; school and college-sponsored class, program, and activity; therapeutic riding program; and any operator, instructor, and promoter of an equine a farm animal facility, including, but not limited to: a stable; clubhouse; ponyride string; fair; and arena at which the activity is held.

(5) "Farm animal facility" means any area used for any farm animal activity, including but not limited to a farm, ranch, riding arena, training stable, barn, pasture, riding trail, show ring, polo field, or other area or facility used or provided by a farm animal activity sponsor or where a participant engages in a farm animal activity.

(5)(6) "Equine Farm animal professional" means a person engaged for compensation in any of the following:

(a) Instructing a participant or renting to a participant <del>an equine</del> <u>a farm animal</u> for the purpose of riding, driving, or being a passenger upon the equine farm animal.

(b) Renting equipment or tack to a participant <u>in a farm animal</u> <u>activity</u>.

(c) Examining or administering medical treatment to an equine <u>a farm animal</u> as a veterinarian.

(6)(7) "Inherent risks of equine <u>farm animal</u> activities" means those dangers or conditions which are an integral part of equine <u>a</u> farm animal activities <u>activity</u>, including but not limited to:

(a) The propensity of an equine <u>a farm animal</u> to behave in ways that may result in injury, harm, or death to persons on or around them.

(b) The unpredictability of an equine's <u>a farm animal's</u> reaction to such things as sounds, sudden movement, and unfamiliar objects, persons, or other animals.

(c) Certain hazards such as surface and subsurface conditions.

(d) Collisions with other equine <u>farm animals</u> or objects.

(e) The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the <u>farm</u> animal or not acting within his ability.

(7)(8) "Participant" means any person, whether amateur or professional, who engages in an equine <u>a farm animal</u> activity, whether or not a fee is paid to participate in the equine farm animal activity.

B. Except as provided in Subsection C of this Section, an equine a farm animal activity sponsor, an equine a farm animal professional, or any other person, which shall include a corporation or partnership, shall not be liable for an injury to or the death of a participant resulting from the inherent risks of equine a farm animal activities activity and, except as provided in Subsection C of this Section, no participant or participant's representative shall make any claim against, maintain an action against, or recover from an equine a farm animal activity sponsor, an equine a farm animal professional, or any other person for injury, loss, damage, or death of the participant resulting from any of the inherent risks of equine farm animal activities.

C. Nothing in Subsection B of this Section shall prevent or limit the liability of an equine <u>a farm animal</u> activity sponsor, an equine <u>a</u> <u>farm animal</u> professional, or any other person if the <u>equine farm</u> <u>animal</u> activity sponsor, <u>farm animal</u> professional, or person either: (1) Provided the equipment or tack, and knew or should have known that the equipment or tack was faulty, and such equipment or tack was faulty to the extent that it did cause the injury.

(2) Failed to make reasonable and prudent efforts to determine the ability of the participant to engage safely in the equine farm animal activity and to safely manage the particular equine farm animal based on the participant's representations of his ability.

(3) Owns, leases, rents, or otherwise is in lawful possession and control of the land or facility upon which the participant sustained injuries because of a dangerous latent condition which was known or should have been known to the equine farm animal activity sponsor, equine farm animal professional, or person and for which warning signs have not been conspicuously posted.

(4) Commits an act or omission that constitutes willful or wanton disregard for the safety of the participant, and that act or omission caused the injury.

(5) Intentionally injures the participant.

D. Nothing in Subsection B of this Section shall prevent or limit the liability of an equine <u>a farm animal</u> activity sponsor or an equine <u>a farm animal</u> professional under liability provisions as set forth in the "Louisiana Products Liability Act", R.S. 9:2800.51 through 2800.59.

E. Every equine farm animal professional and every equine farm animal activity sponsor shall post and maintain a sign conspicuously located which contains the warning notice specified in Subsection F of this Section. The sign shall be placed in a clearly visible location on or near any stable, corral, or arena where the equine farm animal professional or the equine farm animal activity sponsor conducts equine a farm animal activities activity. The warning notice specified in Subsection F of this Section shall appear on the sign in black letters, with each letter to be a minimum of one inch in height. Every written contract entered into by an equine a farm animal professional or by an equine a farm animal activity sponsor for the provision of professional services, instruction, or the rental of equipment or tack or an equine <u>a farm animal</u> to a participant, whether or not the contract involves equine farm animal activities on or off the location or site of the equine farm animal professional's or the equine farm animal activity sponsor's business, shall contain in clearly readable print the warning notice specified in Subsection F of this Section.

F. The signs and contracts described in Subsection E of this Section shall contain the following warning notice: WARNING Under Louisiana law, an equine <u>a farm animal</u> activity sponsor or equine farm animal professional is not liable for an injury to or the death of a participant in equine <u>a farm animal</u> activities activity resulting from the inherent risks of equine the farm animal activities activities activity, pursuant to R.S. 9:2795.1 this Section.

G. Failure to comply with the requirements concerning warning notices provided in this Section shall prevent <del>an equine <u>a farm animal</u></del> activity sponsor or <del>equine <u>farm animal</u></del> professional from invoking the privilege of immunity provided by this Section."
