To amend and reenact R.S. 26:359(A) through (F) and to enact R.S. 26:359(H) and 359.1, relative to the importation of wine by individuals into the state; to provide for the direct shipment of sparkling wine or still wine from out of state to a consumer in Louisiana; to prohibit the unlawful shipment of alcoholic beverages; to provide for the criteria required to ship out-ofstate sparkling or still wine directly to a consumer in Louisiana; to provide for the number of bottles that may be shipped; to delete provisions requiring that a seller or shipper who is a manufacturer cannot be a party to certain agreements in order to ship directly into this state; to require an annual out-of-state shipper's license for authorization to directly sale and ship sparkling wine or still wine into the state; to provide for an exception for a person who is physically present on the premises of the manufacturer; to provide for civil fines for certain violations; to permit interstate shipment of certain wine by common carrier; and to provide for related matters.
