B. The uniform compulsive and problem gambling identification and treatment program shall provide that the holder of any license issued by the board for the conducting of gaming activities as provided by law shall implement the policies and procedures which are adopted by the board and are designed to:

(1) Identify problem gamblers.

(2) Prevent previously identified problem gamblers from gambling at the licensee's facility or other facilities licensed by the state of Louisiana.

C. The policies and procedures shall be developed in cooperation with the office of alcohol and drug abuse for the Department of Health and Hospitals as provided in R.S. 28:841 and shall include the following:

(1) Training of key employees to identify and report suspected problem gamblers.

(2) Procedures for recording and tracking identified problem gamblers.

(3) Policies designed to prevent serving alcohol to intoxicated gaming patrons.

(4) Steps for removing problem gamblers from the licensed establishment or facility.

(5) Procedures for preventing re-entry of problem gamblers.

<u>D.</u> All rules adopted pursuant to the provisions of this Section shall be adopted in accordance with the provisions of the Administrative Procedure Act and R.S. 27:15(B)(8).

E. Nothing herein shall be construed to relieve the licensee from the requirements of posting of signs to inform customers of the toll-free telephone number available to provide information and referral services regarding compulsive or problem gambling as required by R.S. 27:58(10), 249(B), 320, or 377."
