Obviously, appropriately dealing with these health and economic emergencies caused by COVID-19 are our first priority. On the state legislative front, Senate President Paige Cortez and House Speaker Clay Schexnayder have adjourned the 2020 Regular Legislative Session until further notice based on the health and safety of the legislators, staff, media and public. We're following the projections and advice of health professionals to determine when everyone can safely return to the Capitol to handle constitutionally mandated legislative action (*e.g.*, adoption of a balanced budget). Final Adjournment must occur no later than June 1, 2020.

Also, Speaker Schexnayder has assigned certain responsibilities to each of his committee chairmen while we're adjourned. My role as Chair of the House Commerce Committee is to develop a menu of potential legislative instruments designed to stimulate economic activity to help pull us out of the adverse economic effects of COVID-19. The House Commerce Committee is responsible for the following subjects: Commerce generally; Banking and the regulation thereof; Communication by telephone, telegraph, radio and television; Registering and licensing of vessels and small boats; Navigation and laws relating thereto; Regulation of common carriers by water; Consumer protection; Laws relating to merchandising; Regulation, licensing, or certification of occupations and professions generally, except those fields which are health related; Interest rates; Savings and loan and homestead associations; Small loan companies; Regulation and licensing of businesses and occupations; Protection of trade and commerce against unlawful restraints and monopolies; Corporations; and Tourism.
