
FY 16 Governor's Deficit Plan

- The Governor's Deficit plan for the Department of Natural Resources (DNR) totals \$426,156 and includes a \$39,492 reduction in State General Fund, \$377,539 in Statutory Dedications, and \$9,125 in Fees and Self Generated Revenue.
- Statutory Dedications reduced include the Mineral and Energy Operation Fund (\$363,802) and Underwater Obstruction Removal Fund (\$13,737).

- As part of the Governor's plan to solve for the \$2 billion projected deficit for FY 16-17, State General Funds are reduced by \$5 million or 61.7%.
- Statutory Dedications make up 47% of DNR's FY17 budget recommendation. These funds are derived from 7 dedications that are funded through fees on oil and gas production and state mineral leases.
- Interagency Transfers reductions represent reduced funds transferred within DNR agencies.
- Other Charges are being reduced by \$12 million due to obligations fulfilled in FY16 that will not be needed in FY17 (\$1,325,276), reduced transfers to State Offices (\$2,472,876), and lower projected expenditures related to Bayou Corne (\$1,473,308) and the Oilfield Site Restoration program (\$3,206,449).
