Summary of Federal Stimulus Bills

Phase 5- American Rescue Plan Act

Coronavirus State Fiscal Recovery Fund - \$3.01 Billion to Louisiana

- Direct payment to the state in one or two tranches at the discretion of the Secretary of the US Treasury. First Tranche (approx. 50%) in 60 days, and second tranche 12 months later
- Funds can be used for COVID-19 response, premium pay for certain state employees and essential workers, revenue loss, and investments in water, sewer, and broadband infrastructure

Coronavirus Local Fiscal Recovery Fund - \$1.8 Billion to Louisiana

- Estimates predict the Louisiana local funding monies will be distributed as follows:
 - \$571.9 Million for metropolitan cities (paid directly to the city)
 - \$322.4 Million for non-metropolitan areas (paid to the state for distribution to such areas)
 - \$901.6 Million for parishes (paid directly to the parish)
- Same allowable uses as the state fund

Coronavirus Capital Projects Fund - \$179.8 Million to Louisiana

 Paid to the state for critical capital projects directly enabling work, education, and health monitoring, including remote options, in response to the COVID-19 public health emergency

Childcare/Early Childhood Education - \$822.4 Million to Louisiana

- \$298 Million in Child Care and Development Block Grants
- \$48.4 Million for Individuals with Disabilities (Preschool, Infants and Toddlers)
- \$476 Million in Child Care Stabilization Funding

K-12 Education - \$2.6 Billion to Louisiana

- Elementary and Secondary School Emergency Relief Fund (ESSER II) \$2.6 Billion for response to coronavirus (formula funding) school repairs and improvements and economically impoverished, disabled, minorities, and foster care
- \$49 Million allocated for emergency assistance to Non-Public Schools

Higher Education - \$599.5 Million to Louisiana

- The Higher Education Emergency Relief Fund (HEERF) \$480.4 Million to public and private non-profit higher education institutions
- \$113.9 Million estimated to HBCUs and Minority Serving Institutions

Healthcare - \$331.4 Million to Louisiana

- \$140 Million for testing and contact tracing initiatives, with emphasis on testing in schools
- \$139.5 Million for distribution and administration of COVID-19 vaccinations
- \$40.4 Million for Behavioral Health
- \$3.5 Million to track and forecast COVID-19 trends and identify variants
- Medicaid requires coverage of COVID-19 vaccines and treatments at no cost to the patient;
 provides a 100% federal match for all vaccine services
- Medicaid gives states the option to expand coverage to mothers up to a year post-partum
- Medicaid provides increased cost sharing for Medicaid expansion in certain areas of care

Transportation - \$58.2 Billion Nationwide

• Transit Funding - \$30.5 Billion; Aviation Funding - \$26 Billion; Railway Funding - \$1.7 Billion

Veterans - \$17 Billion Nationwide

- Veterans Health Administration (VA) \$14.5 Billion

- Pandemic Emergency Unemployment Compensation (PEUC) additional 53 weeks
- Pandemic Unemployment Assistance (PUA) for "gig workers" extends to a maximum of 79 weeks
- Federal UI borrowing interest free

Small Business Aid

- Paycheck Protection Program (PPP) additional \$7.5 Billion in new funding
- Economic Injury Disaster Loan (EIDL) \$3.6 Billion total, \$386.5 million is appropriated for advance payments on assistance to low-income communities

- Community Navigator Pilot Program \$175 Million

Stimulus Checks - estimated \$5.67 Billion to Louisiana

Maximum direct payments of \$1,400 per individuals and dependents

Tax Provisions

- Exempts \$10,200 of unemployment benefits received in 2020 from federal income taxes for households with income below \$150,000
- Expands the child tax credit and makes changes to the Earned Income Tax Credit

Miscellaneous - \$4.8 Million to Louisiana

- \$3 Million to Louisiana Institute of Museums and Library Services
- \$930,000 to Louisiana National Endowment for the Humanities
- \$820,000 to Louisiana National Endowment of the Arts

Phase 3.5- Paycheck Protection Program and Health Care Enhancement Act

Phase 3- CARES Act

- Coronavirus Relief Fund- \$1.8 Billion to Louisiana for expenditures incurred due to the public health emergency with respect to COVID-19. See U.S. Treasury Guidance for uses and restrictions.
- CDC grants to state and local governments for COVID-19 response.
- Emergency Solutions Grants to state and local governments
- Education
 - Governor's and K-12 Education Stabilization Fund
 - Higher Education Stabilization Fund- which sets aside a portion for HBCU's

 those otherwise ineligible for (including having exhausted) regular UC
 - Short-time compensation programs, existing and new: benefit and administrative costs, plus grants for administration and promotion

Phase 2- Families First Coronavirus Response Act

- Funds for the Special Supplemental Nutrition Program for Women Infants and Children (WIC)
- The Emergency Food Assistance Program (TEFAP)
- SNAP- Gives USDA authority to approve state emergency plans for households with children not receiving the free or reduced lunch program at school.
- Elderly nutrition services- including home-delivered meals and congregate meals.
- Funding for COVID-19 diagnostic testing
- Expands FMLA program for families who no longer have childcare.
- Unemployment Insurance administrative costs and eases requirements on recipients.
- Provides for a state FMAP increase of 6.2% from 66.86% to 73.06% for the state of Louisiana.

Phase 1- Coronavirus Prepared Response Act

- Authorizes Medicare providers to provide telehealth services outside of rural areas.
- Funds for state and local government response activities incurred prior to enactment in early March
- Provides funds for community health centers
- Funds to National Institutes for Health, Department of State and other federal partners for research and response efforts.
