



### OFFICE OF THE SECRETARY

### **Executive Administration**

•Contains the Secretary and his Executive Staff.

### Criminal Investigation

•Investigates negligence and knowing or willful violations of Louisiana environmental law.

#### **Public Information**

•Communicates with the media and citizens on information regarding the department's activities.

#### **Audit Services**

•Performs internal audits on the department.

### Legal Services

•Responsible for the department's legal needs.

### Business, Community Outreach and Incentives Division

•Administers the Drinking Water Protection Program, Small Business/Community Assistance Program, and several other programs.



### OFFICE OF ENVIRONMENTAL COMPLIANCE

### **Inspection Division**

- •Inspects facilities for permit compliance.
- Responds to citizen complaints in regards to unauthorized release of water or air pollution.

#### **Assessment Division**

- Evaluates overall quality of air and water resources.
- Responds to emergency situations or releases of water or air pollution.

### Underground Storage Tank and Remediation Division

• Protects soil and groundwater resources from unauthorized releases of motor fuels from underground storage tanks.

#### **Enforcement Division**

- •Enforces penalties for violations of state and federal laws.
- •Negotiates settlements for violations of state and federal laws.



### OFFICE OF ENVIRONMENTAL SERVICES

#### Water Permits Division

• Authorizes permits administered under Louisiana Water Quality Regulations.

#### Solid and Hazardous Waste Permits Division

- Authorizes permits administered under the Solid Waste and Hazardous Waste Regulations.
- •Provides engineering and geological services throughout the state.

#### Air Permits Division

• Authorizes permits administered under Air Quality Regulations.

### Public Participation and Permit Support Division

- Facilitates public participation through public hearings and informing the public through notices.
- Provides support to permit divisions with administration, database management, certifications, accreditations and notifications.



### OFFICE OF MANAGEMENT AND FINANCE

### Financial Services

- Responsible for accounting of the department.
- Produces financial reports.
- Responsible for Clean Water State Revolving Fund, Motor Fuel Underground Storage Tank Fund and the Waste Tire Program.

### **Support Services**

 Provides support to the department by providing safety trainings and providing information technology assistance.

The Division of Administration estimates that \$437,665 in State General Fund is needed in FY 17 to fully fund projected normal operating costs and other priorities. Therefore, \$275,593 additional SGF is needed to fully fund operations.

### SOURCES OF REVENUE

#### Federal Funds \$19.7 Million

Federal Funds consist of various grants issued by the Environmental Protection Agency, the Department of Energy, and the Department of Defense.

### Statutory Dedications \$96.2 Million

the Environmental
Trust Fund (\$62.2M),
the Motor Fuels

### Self Generated \$24,790

Fees and Self-generated Revenue is made up of the sale of forms and solid waste certification fees.

### Interagency Transfers \$441,000

Interagency Transfers are made up mostly of a single transfer (\$350,000) from the Louisiana Office of Homeland Security and Emergency Preparedness, which is used for hurricane related demolition and landfill oversight.

# SIGNIFICANT ADJUSTMENTS

\$1.6 M

Increase in budget authority for the Environmental Trust Fund for the department's Mobile Air Monitoring Laboratory (MAML). This is funded entirely by a donation to the Environmental Trust Fund from Phillips 66 and Marathon Petroleum with the requirement that the donation be used for the procurement of the MAML.

\$1.4 M



Increase is to the Environmental Trust Fund and the Hazardous Waste Site Cleanup Fund to restore the funds to their levels before the first FY 16 mid-year budget reduction.

\$615,397



Increase in budget authority for the Hazardous Waste Site Cleanup Fund for additional site remediation work.




Reduces the appropriation for the Louisiana Rural Water Association by 63%, for a proposed appropriation of \$162,072 in FY17. The Association assists small water and wastewater systems through training, technical assistance and state operator certifications.


