### **BOARD OF REGENTS**

The mission is to plan, coordinate, and have budgetary responsibility for all public, postsecondary education as constitutionally prescribed in a manner that is effective and efficient, quality driven, and responsive to the needs of citizens, business, industry and government.

The Board of Regents (BOR) serves as the state liaison to Louisiana's accredited, independent institutions of higher learning. The Board of Regents is not involved in overseeing the day-to-day operations of college campuses, but is responsible for setting important statewide standards including minimum admissions requirements as well as benchmarks and targets.

#### SPONSORED PROGRAMS

BOR administers state and federal programs that provide funds and other resources to Louisiana's post-secondary education community and interacts extensively with institutions and governmental agencies on issues related to post-secondary research and educational enhancement, recruitment of graduate fellows, and endowment chairs.

### LOUISIANA UNIVERSITY MARINE CONSORTIUM (LUMCON)

The Louisiana Universities Marine Consortium (LUMCON) conducts basic and applied research that increases the scientific understanding of Louisiana's marine and coastal environment by:

- Serving as a facility for all Louisiana schools with interests in marine research and education in order to make all levels of society increasingly aware of the economic and cultural value of Louisiana's coastal and marine environments.
- Sponsoring and coordinating educational events, conducting educational programs, and developing educational products in the marine/coastal sciences for universities, K-12 schools and the public that makes use of LUMCON's location and facilities.



LUMCON offers K-12 and teacher education programs at the Marine Center and elsewhere. The table to the right represents FY 14-15 figures. The field trips, camps, and workshops were all held at the Marine Center. Outreach events include classroom visits, community festivals, and conferences. The Marine Center is located approximately 85 miles southwest of New Orleans in Cocodrie, Louisiana.

# LOUISIANA OFFICE OF STUDENT FINANCIAL ASSISTANCE (LOSFA)

The mission of LOSFA is to facilitate the progression towards college access and success by educating students and families about careers and the related college options, applying to attend college, showing up on campus and persisting beyond the first year.

LOSFA provides college access assistance to high school students across Louisiana through seminars, workshops and special events designed to motivate, instruct and follow through.

LOSFA administers the Taylor Opportunity Program for Students (TOPS) scholarship program, the college savings plan called Student Tuition Assistance and Revenue Trust (START) Saving Plan, the Louisiana Go Grant, and other assistance programs.

#### **TOPS PROGRAM**

A program of state scholarships for LA residents who attend either one of the LA Public Colleges and Universities, schools that are a part of the LA Community and Technical College System, LA approved Proprietary and Cosmetology Schools, or institutions that are a part of the LA Association of Independent Colleges and Universities.

#### START SAVING PROGRAM

The program is a college savings plan designed to help families contend with the growing costs of educating their children after high school.



#### **GO GRANT PROGRAM**

The program provides a need-based component to the state's financial aid plan to support nontraditional and low to moderate-income students who need additional aid to afford the cost of attending college.

### LOUISIANA STATE UNIVERSITY SYSTEM

LSU institutions range from a two-year college, masters granting four-year institutions, doctoral granting institutions on up to a major research university, as well as an Agriculture Center. In addition, LSU provides a comprehensive group of professional schools ranging from law, veterinary medicine, medicine, dentistry, and the full spectrum of allied health professions.



LSU also consists of standalone research centers such as the Pennington Biomedical Research Center, the Lions Eye Center, the Stanley Scott Cancer Center, and the Center for Advanced Microstructures and Devices (CAMD).

In 1997, LSU was charged with the responsibility of administering 10 public hospitals previously under the authority of the Louisiana Health Care Authority. Beginning in 2013, LSU transitioned the management and/or services of its hospitals (except for Lallie Kemp) to private hospital partnerships.





# SIGNIFICANT ADJUSTMENTS

The FY 16-17 Executive Budget recommends a State General Fund reduction of \$180.3 million to universities, colleges, specialized institutions and boards, and a \$233.2 million reduction to LOSFA and TOPS in order to balance to the projected shortfall.

• The State General Fund reduction to the TOPS program leaves only the statutory dedications in the amount of \$60.3 million to fund the entire program.

The Executive Budget recommends a \$350 million reduction in the statutory dedications from the Higher Education Initiatives Fund (SAVE Credit Program) and replaces those funds with State General Fund.

The Executive Budget also reduces \$51.3 million in State General Fund for legislative items that were funded in the current year's budget. These items include:

- \$30.91 million for LSU Health Sciences Center in Shreveport
- \$4.47 million for Southern University Board of Supervisors for allocation to its institutions
- \$4.46 million for LCTCS for Competitive Core Funding
- \$3.98 million for Pennington Biomedical Research Center
- \$2.48 million for LSU Health Sciences Center in New Orleans
- \$1.99 million for LSU Agricultural Center
- \$1.99 for Grambling State University
- \$525,000 for Louisiana Tumor Registry
- \$486,939 for Louisiana Cancer Research Center

# SIGNIFICANT ADJUSTMENTS

The FY 16-17 Executive Budget increases self-generated revenue budget authority by \$8.5 million to properly align expenditures to revenues generated and \$42.1 million for the annualization of fee increases provided by Act 377 of the 2015 Regular Legislative Session. The Act provided authority to impose per credit and differential fees for certain programs and to charge proportional amounts for part-time students and summer sessions.

The Executive Budget moves all 19,483 total authorized positions off budget.

The following slide attempts to illustrate the magnitude of the reduction in State General Fund (SGF) to the various universities, colleges, specialized institutions and boards based solely on the executive budget recommendation and that the Go Grants Program within the Louisiana Office of Student Financial Assistance (LOSFA) would be fully funded.

State General Fund equivalent is considered resources that otherwise would have been classified as State General Fund support for higher education. The SGF equivalent includes the current amount budgeted in SGF plus the amount in statutory dedications from the Higher Education Initiatives Fund (SAVE Credit Program). These two items combine for a starting amount of \$999.9 million, \$649.9 million in SGF plus \$350 million in statutory dedications. This total is then compared to the FY 16-17 proposed \$570.9 million State General Fund executive budget amount and allocated by the same relative portion of their existing SGF equivalent amount. The tables display major reductions across the entire post-secondary system.

### HIGHER EDUCATION FUNDING FORMULA


The Board of Regents is responsible for developing the higher education funding formula.

The Board of Regents approved the initial FY 16-17 funding formula recommendation at their March 23, 2016 board meeting.

#### According to the Board of Regents:

- This preliminary recommendation is based on distributing available funds in the executive budget through the outcomes-based funding formula models for 2 and 4-year institutions and a pro-rata distribution for the specialized institutions.
- With regard to the 2 and 4-year institutions, 70% of the distribution is based on each institution's existing operating budget base, 15% is based on cost, and 15% is based on outcomes.
- The final distribution will be determined by the funds appropriated in the enrolled version of the appropriations bill (HB 1) and will be presented for approval at the June 2016 board meeting.



### TOPS FUNDING SHORTFALL PROCEDURES


LOSFA rules provide for a process to reduce awards if insufficient funds are available to meet the program's demand. The number of eligible students would be reduced in the following order:

The first group of students considered ineligible would be those applicants who did not submit financial data on the initial Free Application for Federal Student Aid (FAFSA) or a renewal (current) FAFSA form.

The remaining students would then be prioritized according to the American College Test (ACT) score and by Expected Family Contribution (EFC) in ranges of \$1,000 from lowest to highest. The EFC is an estimate of the parents' and/or student's ability to pay the student's tuition. The process begins with students with the lowest ACT score and highest EFC, meaning that students who scored a 17 on the ACT and beginning at the highest EFC would be next group eliminated, continuing with students with a score of 17 with each lower EFC until the amount appropriated is sufficient to pay the remaining TOPS awards. If all of the students with an ACT score of 17 are eliminated, then the process would begin again with the next higher ACT score (18, then 19, etc.) in the same method until the amount of the appropriation is sufficient to pay the remaining awards.

According to LOSFA estimates, students would need at least a <u>28 on the ACT</u> to qualify for TOPS awards based on the current FY 16-17 executive budget amount. A relatively small group of students who scored a 28 on the ACT would not be eligible based on the EFC amounts.

### WHERE THE TOPS MONEY GOES FY14-15





#### GRADUATION RATES AMONG TOPS AND NON-TOPS STUDENTS




