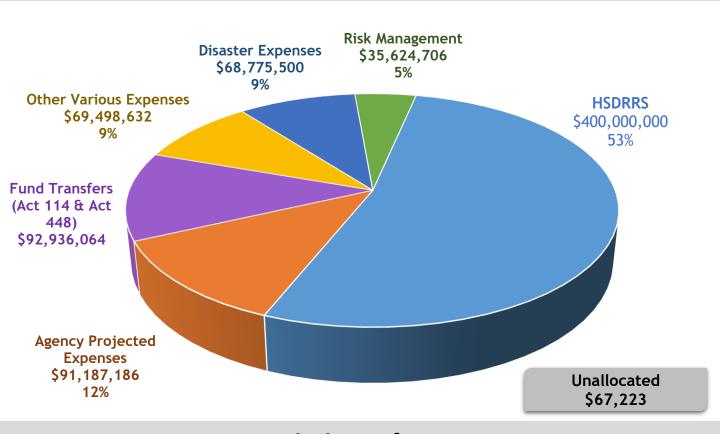

- 1. Fund Transfers State General Fund moved into specific special funds in the state treasury through directives in Act 114 and Act 448
- 2. Disaster Expenses State cost share of expenses related to disasters including recent hurricanes, the winter storm, and past emergency declarations. Also includes the Hazard Mitigation Grant Program
- 3. Agency Projected Expenses Funding to ensure agencies meet anticipated year-end expenses
- 4. Other Various Expenses Specific line-item appropriations to state agencies or local municipalities
- 5. Risk Management Funding for certain agency premiums
- 6. HSDRRS Funding toward the obligation for the Hurricane Storm Damage Risk Reduction System
